All prices are exclusive of V.A.T. which is charged at ruling rate.

All items offered subject to being available at collection or at the time of loading.

Prices may be subject to alteration without prior notice.

Goods are not tested or sold fit for any particular purpose and any term warranty or condition express implied or statutory to the contrary is excluded. In no circumstances whatsoever shall the Sellers liability (in contracts, tort or otherwise) to the Buyer arising under, out of or in connection with this contract or the goods supplied hereunder exceed the invoice price of the particular pieces(s) concerned. The Seller shall be under no liability for loss or damage or delay howsoever arising caused by circumstances outside his control.

Title to the goods shall in no case pass from the Company until the full contract price has been received. If notwithstanding that the property in the goods has not passed to the Buyer, the Buyer shall sell the goods in such a manner as to pass to a third party a valid title to the goods, the buyer shall hold the proceed of such a sale on trust for the Seller. Nothing herein shall constitute the Buyer the Agent of the Seller for the purpose of any such sub-sale. The Company shall have a particular and lien over the goods sold and for all claims and the monies owing to the Buyer to the Company under any contract whatsoever or in any other way whatsoever until the full contract price has been received.

Most of our goods supplied are either bespoke or machined to order and cannot be returned or refunded once the order has been placed and manufacturing has started. If the goods are faulty we will either exchange or provide a refund once we have inspected the goods and agreed the claim. We reserve the right to make a charge to cover the extra costs involved in accepting the return of goods incorrectly ordered. There is a 20% handling and re stocking charge on the return of goods incorrectly ordered. We will only accept returns with original invoice. We will not take back goods that have been machined or cut to order.

If offcuts are required from material we cut for you this must be specified at time of ordering otherwise they will be disposed of at the time of cutting.

Notice of any claim arising out of or in connection with this contract must be given in writing to the Seller within 4 working days from the date when the goods are collected or delivered, failing which all claims shall be deemed to be waived and absolutely barred.

In any event the Buyer gives written notice of claim otherwise than on a consignment note or delivery document to the carrier and to the Seller.
